## ABSTRACT

**KUHS – Exam General (A) – Prescribing the limit of the number of candidates appearing per day, for the Post Graduate Degree /Diploma/ Super Specialty Practical Examinations under all streams – Decision No. 42.10 of the 42<sup>nd</sup> Board of Examinations - Implemented – Orders issued.**

## ORDER

It has been observed that the Course Regulations pertaining to various Post Graduate/Super Specialty courses under the University do not specify the number of students permitted to appear per day for the University Practical Examinations. This leads to unevenness in the number of students appearing for the University practical Examinations.

2. In order to ensure uniformity in the conduct of these examinations, the matter was discussed in the 41<sup>st</sup> meeting of the Board of Examinations and vide paper read as 1<sup>st</sup> above BoE recommended that **"the number of students appearing for the Post Graduate Practical Examinations shall be limited to 6 per day for all streams (unless otherwise specified by the Course Regulations) conducted by the University"** and this recommendation was subsequently ratified by the 83<sup>rd</sup> meeting of the Governing Council vide paper read as 2<sup>nd</sup> above.

3. However, during implementation, a significant discrepancy has been noticed between the prescribed limit of six students per day and the actual number of students being accommodated in certain academic streams. This inconsistency raises legitimate concerns regarding the sustainability and practical applicability of the existing policy when applied uniformly among all disciplines.





4. In view of the above, the matter was placed before the 42<sup>nd</sup> meeting of the Board of Examinations for reconsideration and appropriate decision. After detailed discussion, the BoE vide paper read as 3<sup>rd</sup> above resolved to recommend the following:

- To prescribe a limit to the number of students appearing per day for the Post Graduate/PG Diploma/ Super Specialty Practical Examinations under various streams conducted by the University, unless otherwise specified by statutory regulatory bodies.
- This shall take effect for examinations notified from the date of issuance of the implementation order.
- The prescribed limit of candidates per day appearing for practical examinations for each PG course shall be as tabulated below:

In light of the above, the Hon'ble Vice Chancellor has accorded sanction to implement the above recommendations of the 42<sup>nd</sup> meeting of the Board of Examinations with respect to prescribing the limit of the number of candidates appearing per day, for the Post Graduate Degree /Diploma/ Super Specialty Practical Examinations under all streams, and shall take effect from examinations notified from the date of issuance of this order, subject to ratification by the Governing Council.
