ORDER

The respective Scrutiny Committees of various streams, completed the verification process via online mode in accordance with the criteria prescribed in the PhD Regulations, 2018, vide read (3) above and recommended the five applicants as listed in the Table A as PhD Supervising Guides under KUHS. However, these applicants had not submitted their PG Council Registration Certificates, which is a requirement for verification of their genuiness, as per AC decision (4) and (5) above.
