Order

As per the ref (2) cited above, the 15th meeting of Board of Examinations held on 16/04/2018 has considered, among others, the Report of Sub Committee of BoE (constituted as per the resolution of the GC) with respect to the issue of normalizing the marks of Ayisha Jasla K K (Reg: No. 160020601), a candidate of First year BDS Regular/Supplementary Examinations, August - 2017 at Govt. Dental College, Kozhikode. The issue arose as the candidate happened to write the examinations with QP Code 102002 & 103002 instead of 112002 & 113002, followed by the recommendation of M&LEC to cancel the examination which was rejected by the Governing Council vide paper read as (1) above.

The BoE considered the marks secured by the candidate in both the above examinations and found that the marks secured in the supplementary examination is more advantageous to the student. The Board of Examinations discussed the matter in great detail and decided to cancel the regular examination (First year BDS Reg./Supp. Examination August, 2017) written by the candidate and to consider the result published in the supplementary examination as the first/regular chance.

The 45th meeting of Governing Council held on 21.04.2018 has approved the decision of Board of Examinations with respect to cancellation of QP Codes 102002 & 103002 of regular examination (First year BDS Reg./Supp. Examination, August 2017), written by Ms. Ayisha Jasla K K, (Reg. No. 160020601) and **to consider the result published in the supplementary examination** (February-2018) **as the first/regular chance** vide paper read as (2) above.

Vide reference (3) cited above, the Honourable Vice Chancellor has accorded sanction to implement the decision of Governing Council with respect to the recommendations of the BoE on the Report of Sub Committee.

Accordingly, the earlier University Order read as paper (1) above, issued as per the decision of the GC dated.29.12.2017 stands cancelled and the result of the candidate with respect to First year BDS Regular/Supplementary Examinations, February-2018 will be published considering it as her first regular chance.
