Order

The 88th meeting of M&LEC has considered among others, the case of awarding exorbitant marks by the first evaluator to one candidate who has written only few points related to the first essay question in the answer book and has written some Bible quotes for the rest of the answer and for other questions also. The case was identified by the camp officer of the centralized evaluation camp at KUHS Headquarters while verifying the score sheets for data entry. The first evaluator, Dr.J.Jaslin Edward, Assoc. Professor of Sree Krishna College of Pharmacy and Research Centre, Parassala & the second evaluator Smt. Jeethu Joy, Asst. Professor of Chemists College of Pharmaceutical Sciences and Research ,Ernakulam were summoned for hearing for giving marks for wrong answers and for not reporting the case respectively. On hearing, Dr. J. Jaslin Edward, Assoc.Professor of Sree Krishna College of Pharmacy and Research Centre, Parassala agreed that he has not read the answers properly and marks were awarded by reading heading only. The Committee opined that there is very serious lapse on the part of the aforesaid evaluator and recommended to inform his college about his lapse. Committee also recommended to debarring him from further Examination duties for a period of one year as per Exam Manual Clause I (B) 1 (b) Chapter XII. It was also recommended to direct the candidate to appear before the next MLEC, vide paper read as (1) above.

The 51st meeting of Governing Council held on 28/02/2019 has considered the recommendations of the Malpractices and Lapses Enquiry Committee and resolved to **debar Dr. J Jaslin Edward, Associate Professor of Sree Krishna College of Pharmacy and Research Centre, Parassala from further University Examination duties for period of one year as per Examination Manual Clause 1B 1b. It was also resolved to inform his college Principal about his lapse and to debar him from Internal Examinations for the next two years,** vide papers read as (2) above.

Vide reference (3) cited above, the Honourable Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the recommendations of the Malpractices and Lapses enquiry committee .
