After examining all the details of the issue the University has decided to cancel the provisional registration granted to 33 students of Third Professional MBBS Part-I Regular Examinations, January, 2020 of SR Medical College and Research Centre, Varkala , consequent to the decision of the Govt. of India, Ministry of Health and Family Welfare department, vide U.O read as (1) above.

In the wake of the Central Government directive, the Government of Kerala have withdrawn the Essentiality Certificate issued to SR Medical College and Research Centre, Varkala, vide paper read as (2) above.

Twenty three students of SR Medical College and Research Centre, Varkala, Thiruvananthapuram registered for the aforesaid examination have filed a writ petition before the Hon'ble High Court of Kerala seeking permission to write the examination. The Hon'ble High Court of Kerala has directed the University to permit the petitioners to write Third Professional MBBS Part-I Regular Examinations, January, 2020 commencing from 10<sup>th</sup> January 2020. The court has also directed the University to evaluate the answer books of the petitioners who take the examination but not to publish their results until further orders, vide paper read as ( 3) above.

In the above circumstances the University have examined the matter in detail and decided the following:-

- a. Twenty three candidates (ie. petitioners) of SR Medical College and Research Centre, Varkala, Thiruvananthapuram registered for Third Professional MBBS Part-I Regular Examinations, January, 2020 are permitted to take the examination, subject to the final disposal of WP (C) No. 26/2020 .

- b. The results of these candidates pertaining to the aforesaid examination will not be published until further orders from the Hon'ble High Court of Kerala.
- c. These candidates will not have any further right, equity etc with respect to the permission granted to them by the University to write the examination.
- d. As the college has ceased functioning ,followed by the cancellation of Essentiality Certificate issued by the Govt, of Kerala, the aforesaid theory examination for the petitioners will be conducted at KUHS Headquarters as per the time table already published.
- e. The venue and schedule for practical examination will be announced in due course.
- f. The admission tickets to the petitioners will be issued directly from the University on 09.01.2020.

Orders are issued accordingly.
