The meeting of Standing Committee of Governing Council, held on 20/03/2020, has resolved the following subject to ratification by Governing Council, vide paper read as (2) above:-

- 1) to approve the recommendations of Malpractices and Lapses Enquiry Committee, with a clarification that the candidates should be debarred from the next chance of the corresponding examinations in which they were caught for malpractice as detailed in the table above.
- 2) Committee also considered the appeal submitted by Bincy C.U stating that she has carried only questions in the bit of paper caught from her. The committee has verified the bit of paper which was caught from the candidate and observed that it contains points related to the subject in which examination was conducted and could be helpful in answering the questions. Hence approved the recommendations of the M&LEC.
- 3) Committee also recommended to advice the M&LEC to be more precise in specifying the examination in which the candidate should be debarred in the next chance, whether it is the next whole examination or the particular examination on which the malpractice is being identified.

The 59^{th} meeting of Governing Council, vide agenda no 59.32 have resolved to approve the decisions of the meeting of Standing Committee of Governing Council, held on 20/03/2020, with respect to the cancellation of examinations and debarring of concerned students, vide paper read as (3) above.
