ORDER

As per the paper read (1) above, University has made ordinance on transfer of Compulsory Rotating Internship(CRRI). As per Clause 1 Chapter III of the Ordinance, a maximum of 5% of the permitted yearly admission capacity of students of the college shall be allowed transfer. Clause 3 Chapter II of the Ordinance stipulates that " in the case of MBBS students the posting in community medicine (2 months) shall be done in the college of study under department of Community Medicine in all cases. Only the rest of the CRI is allowed to be transferred".

2. Vide paper read (2) above, the Government of Kerala issued new guidelines for CRRI transfer. As per the G.O, transfer is restricted to 5% of the sanctioned intake of the college during the year.

3. As per the paper read (3) above, the Board of Governors in super session of Medical Council of India has clarified that in view of COVID 19 pandemic no permission or No Objection Certificate or clearance is required from MCI for undergoing internship in any approved medical institution provided the Dean/ Principal of the Medical College in which the student is studying allows the same.

4. University has received many applications for internship transfers in excess of five per cent limit stipulated in the University ordinance . University has also received requests for permission to do the 2 months Community Medicine part of CRRI in the institution to which CRRI is allowed.

5. The whole matter was placed before the 60th Governing Council meeting. Considering the new guidelines for CRRI from MCI & considering the situation due to Covid-19 pandemic, Governing Council decided to permit CRRI transfer to the students to approved district/general hospitals over and above the 5% limit of the actual intake and to do all postings including 2 months community posting in the institution where CRRI transfer is allowed, as a onetime relaxation to the norms in clause 1 & 3 chapter II of the ordinance on CRRI.

6. Sanction has been accorded by the Hon'ble Vice Chancellor to implement the Governing Council decision read as (4) above.



7. Orders are issued accordingly.
