Vijayakumar under section 28(2)(d) of KUHS Act 2010 and Dr .Pushpa Kizhakkekarammel, Addl Prof Microbiology, GMC Manjery is nominated to the resultant vacancy of Dr. Kannan Vaidyanathan as the member of the Board of Studies of Pre clinical PG (Medical ) under section 28(2)(c) of the KUHS Act.


