### ORDER

As per the paper read (1) above, the meeting of Board of Studies of UG Nursing dated 14.09.2021 reviewed and modified the MSR, Course, syllabus, regulations, scheme of examination, to prepare an addendum to the revised regulations and curriculum for BSc Nursing programme by INC.

The above minutes of Board of Studies of UG Nursing was placed before the Faculty of Nursing dated 12.10.2021.

Vide paper read (2) above, the Faculty of Nursing has recommended to implement the revised curriculum in totality for the BSc Nursing programme from the academic year 2021-22 in a phased manner, as the process of affiliation of BSc Nursing programme are getting over or in progress based on the existing MSR and the applications are already invited from candidates for admission to the BSC (N) programme for the academic year 2021-22. Hence the revision of MSR and criteria for selection of candidates to BSC (N) programme based on Entrance examination conducted either by the University or by the State Govt. was decided to implement in a phased manner from next academic year (2022-2023) onwards. A Faculty orientation regarding the implementation of revision through online platform was also suggested.

It was suggested to add a comprehensive set of Model Question papers, References and Transcripts in the revised syllabus and to prepare model Mark lists for all semesters. Meeting decided to ensure 100% attendance in practical subjects before issue of Provisional Degree



Certificates once the revised scheme is implemented.

In the circumstances, sanction is hereby accorded to implement the above decisions of Faculty of Nursing, considering the fact that cut off date of admission for 2021-22 is 31.12.2021 and classes is slated to commence on 01.01.2022, subject to ratification by Academic Council and Governing Council.
