### ORDER

1. The Academic Council meeting held on 05.03.2020 vide decision No. 24.30 read 1<sup>st</sup> above was decided to make the following amendment to clause 1 of the 1<sup>st</sup> ordinance Chapter III-Transfer of Compulsory Rotating Internship (CRI)

"Transfer of CRRi is not a right. But it is granted in situations where the student has genuine difficulty in completing the CRRi in the college of study. A maximum number of 5 % of the permitted yearly admission capacity of students of a college can be allowed internship transfer to another college. However, internship transfer shall be allowed without insisting the above 5% limit to Government General /District Hospitals approved by apex council on production of NOC "

2. The 59<sup>th</sup> Governing Council meeting held on 25.04.2020 vide decision No. 59.28 read 2<sup>nd</sup> above decided to constitute a sub committee with Dr. A.RemlaBeevi, DME, Dr. Aswini Kumar, GC member and Dr.K.Ambujam Dean, Faculty Of Medicine as members for





detailed discussion and to suggest the upper limit of transfer. The sub committee recommended that the original ordinance limiting the CRR transfer of candidates to 5% be continued as such.

3. The report of the sub committee was placed before the 60<sup>th</sup> meeting of the Governing Council held on 25.07.2020. Governing Council vide decision number 60.13 read 3<sup>rd</sup> above approved the recommendations of the committee that the original ordinance limiting the CRR transfer of candidates to 5% be continued as such.

4. As per Sec 43(ii) of KUHS Act "Governing Council shall not have the power to amend any draft proposed by the Academic Council ( except those permitted u/s 43(i) , but may return it to the Academic Council for reconsideration in part or in whole together with any amendments which the Governing Council may suggest."

5. The 25<sup>th</sup> Academic Council meeting held on 30.09.2020 vide decision No.25.04 read 4<sup>th</sup> above decided to accept the recommendation of the Governing Council vide decision 60.13(2), that the clause 1 in the ordinance for CRR transfer, limiting the CRR transfer of candidates to 5% be continued as such and decided to cancel the AC decision 24.30 to amend clause 1 of the 1<sup>st</sup> ordinance Chapter III Transfer of CRR.

6. Hon'ble Vice Chancellor has accorded sanction to implement the Academic Council decision No.25.04.

7. Orders are issued accordingly.
