ABSTRACT

KUHS-Academic- Clause 2(5)(v) of the modified affiliation statute -Further modification subject to approval - sanctioned-orders issued

ORDER

1. The 17th Academic Council meeting vide decision read (1) above has approved the modifications/amendments made in the existing affiliation statutes and resolved to make it as separate affiliation statute. The resolution was approved by the 42nd Governing Council vide decision read (2) above and submitted the same to Government of Kerala for approval. Accordingly, the Government approved the amendment proposals of the 1st statute.

2. The Governing Council meeting held on 26.08.2019 vide decision read 3rd above decided to forward the amendment proposals to the Hon'ble Chancellor for assent.

3. Subsequently, Hon'ble Chancellor approved the amendments in affiliation statute and forwarded it to the Government for publishing in Kerala gazette .The amendment was published in the Gazette with notification No. 2035/AC-H/2015/KUHS Dated 24.02.2020 and came in to force with effect from 02.12.2019.

4. As per this amended Affiliation statute (amendment of the 1st statute on the matter of affiliation of Colleges) clause 2 5(v) "*In the case of additional courses and/or for enhancement of seats , the colleges shall satisfy the condition that 1st batch of the courses in the institution under the same stream shall be passed out and the details of the average of pass percentage of previous regular examinations of all existing batches of the same course at the time of submitting the application and a declaration that the percentage is not below the minimum prescribed by the Governing council in the Notification issued by the University for the purpose of the addition/enhancement concerned*".

5. Now, the University is facing with several issues while processing applications for additional courses and /or enhancement of seats invoking the above clause as the intended objective of the amendment is not seen met with. To explain further, it is found that while processing applications for provisional affiliation of starting new course / enhancement of seats, most of the applications are being rejected as the first batch of all courses in the institutions may not have passed out making it practically impossible to sanction additional courses or enhancement of seats in the existing affiliated courses.

6. Now that several applications for starting additional courses/enhancement of seats are hit a roadblock due to the amendment which does not meet the bonafide objective, and considering the severe time constraints to get the



amendment modified through fresh notification after getting approval from all statutory bodies, sanction is hereby accorded by the Hon'ble Vice Chancellor to modify the Clause 2(5)(v) of the amendment of the 1st statute for starting additional courses and/or enhancement of seats and to process the applications received based on the following norms, till further amendment in affiliation statute are made, subject to ratification of Academic Council and Governing Council.

A. For additional course the average of pass percentage of all regular examinations of the existing batches of all courses under the same stream is not below the minimum prescribed by the Governing council in the Notification Issued by the University from time to time for the purpose of the additional course concerned. If the norm above is contrary to the norm of apex council if any, then the norm of apex council shall prevail*.

B. For enhancement of seats the first batch of the same course to which enhancement is requested by the college shall be passed out and the average of pass percentage of all regular examinations of the existing batches of that particular course is not below the minimum prescribed by the Governing council in the Notification Issued by the University from time to time for the purpose of the enhancement concerned. If the norm above is contrary to the norm of apex council if any, then the norm of apex council shall prevail*.

7. Orders are issued accordingly.
