ORDER

The 35th meeting of the Board of Examinations had decided to continue with the system of sanctioning Airfare to the examiners coming from outside the state for UG examination with the prior permission of Hon'ble Vice Chancellor on submitting all the enlisted requests of External Examiners through the Convener of Practical Examination, sufficient early vide paper read (1) above.

Subsequently, the Conveners of Practical Examination submit the details of external examiners as and when they confirm to take up the assignment. The conveners have expressed the practical difficulties to submit a single list of external examiners sufficiently early, to the examination Section concerned. This results in undue delay in getting permission for air travel from Hon. VC. The delay in confirmation of appointment leads to the difficulty for external examiners in relieving from the college, booking air tickets etc. The same difficulty arises when the External Examiners decline their duty and substitutes are appointed at the last moment.

The 36th meeting of BoE held on 13/07/2023, has considered the aforementioned matter and decided to permit air travel to the Examiners coming from outside the state for UG examinations. Ex post facto sanction may be accorded for their journeys.

The 75th meeting of Governing Council held on 29.07.2023 considered the above matter and resolved to approve the same, vide paper read as (3) above.

The Hon. Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the Payment of flight charges to the examiners coming from outside the state for UG examinations.

The University order read (1) above stands modified to this extent.
