KUHS – Examination -Granting of compensatory time for students with 40% Permanent Disability during a course period as one time measure-orders issued.

ORDER

As per the First Statutes Chapter I 13 A (v) and provisions in the Chapter XIII of the Examination Manual, Hon'ble Vice- Chancellor has the power to grant compensatory time as per rules for students with 40% or more Permanent Disability, based on the Certificate issued by the Competent Medical Board. **The applications for compensatory time shall be submitted to the University 30 days before the commencement of the examination , through the Principal concerned.** As per the orders of the Hon'ble Vice Chancellor, separate orders are being issued by allotting compensatory time for each and every examination for the students with disability, during their entire course period.

Currently, orders for allotment of Compensatory time need to be issued for eligible candidates while appearing in each examination during the entire course period. Besides this, often there is undue delay in receipt of requests for Compensatory time leading to difficulties in issuing orders for allocating compensatory time. The 36th meeting of BoE held on 13/07/2023, considered the matter and recommended to issue a single order for grant of compensatory time to eligible candidates upon request, (with 40% or more Permanent Disability, as per the Standing Disability Certificate issued by the Competent Authority in the prescribed format) encompassing all examinations the candidate is due to write during the entire course period instead of separate orders for each examination, vide paper read as (1) above.

The 75th meeting of Governing Council held on 29.07.2023 considered the above matter and resolved to approve the same, vide paper read as (2) above.

The Hon. Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to granting compensatory time to eligible students with Permanent Disability upon request, by issuing a single order for grant of compensatory time to eligible candidates, (with 40% or more Permanent Disability, as per the Standing Disability Certificate issued by the Competent Authority in the prescribed format) encompassing all examinations the candidate is due to write during the entire course period, based on the valid Disability Certificate submitted .





Orders are issued accordingly.
