## ORDER

The DVD/CD verification reports of various theory examination centres reveals that many of the colleges are not following the Guidelines issued by the University. Most of the recordings of surveillance of examination hall turned to be poor quality and blurred vision makes verification and identification impossible, the seating arrangements and distancing are not as prescribed by the University.

The 36<sup>th</sup> meeting of BoE held on 13/07/2023, has considered the matter and recommended to conduct Squad inspection regarding the facility of theory examination centres and Remote Digital Evaluation Centres and to take necessary remedial/disciplinary action if required. The BoE authorized the Controller of Examinations to conduct Squad inspection regarding the facility of theory examination centres and RDEC and to take necessary remedial/disciplinary action if required.

Principals of all affiliated colleges are directed to modify the facilities of their Theory Examination centres / Remote Digital Evaluation Centres as required by the University **before 30.09.2023**. District / Zone wise inspections will be conducted to assure the mandatory requirement of Examination centres. Non compliance of stipulated norms leads to cancellation of Theory Examination centre/ RDEC status.

The 75th meeting of Governing Council held on 29.07.2023 considered the above matter vide agenda No.75.43 and resolved to approve the same, vide paper read as (2) above.

The Hon. Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to Squad inspection to check the Facilities of Theory Examination Centres / Remote Digital Evaluation Centres.
