The 75<sup>th</sup> meeting of Governing Council held on 29/07/2023 vide Agenda No.75.43 has considered the recommendations of BoE and resolved to approve the same, vide paper read as (6) above.

The Hon. Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to granting of Remote Digital Evaluation Centre (RDEC) status to 39 Pharmacy Colleges for the digital evaluation.
