### **ORDER**

The Criteria of pass in the B.Pharm (Ayurveda) Course as per the Academic Regulation of B Pharm Ayurveda for 2016 -2017 admission, is "A candidate should secure 50% marks in University Theory and Practical separately" and as per the Course Regulation of B Pharm Ayurveda for 2016 -2017 admission, the minimum pass mark required for theory and practical is 45% separately.

As per the paper read as (3) above, "The pass criteria of B.Pharm (Ayurveda) is 50% separately for theory and practical as mentioned in the Academic Regulations 2016 from 2020-21 admissions onwards. The pass criteria for 2016-2017, 2017-2018, 2018-2019 and 2019-2020 admissions are 45% for theory and practical separately."

Hon'ble Vice Chancellor has approved the pass criteria from the 2020-21 admission of B Pharm Ayurveda as new scheme of examination subject to the ratification by the Board of Examinations.

The 35<sup>th</sup> meeting of BoE held on 07/02/2023, vide its agenda no. 35.05 has considered the matter and resolved to ratify the action in having approved the pass criteria from the 2020-21 admission of B Pharm Ayurveda as a new scheme of examination with the pass criteria of 50% separately for theory and practical as mentioned in the Academic Regulations 2016 from 2020-21 admissions onwards. The pass criteria for 2016-2017, 2017-2018, 2018-2019 and 2019-2020 admissions are 45% for theory and practical separately vide paper read as (4) above.

The 73rd meeting of Governing Council held on 25/02/2023 has considered the afore mentioned



recommendations of BoE and resolved to approve the same, vide paper read as (5) above.

The Hon'ble Vice Chancellor has accorded sanction to implement the decision of the Governing Council with respect to the pass criteria from the 2020-21 admission of B Pharm Ayurveda as a new scheme of examination with the pass criteria of 50% separately for theory and practical as mentioned in the Academic Regulations 2016 from 2020-21 admissions onwards. The pass criteria for 2016-2017, 2017-2018, 2018-2019 and 2019-2020 admissions are 45% for theory and practical separately.

Orders are issued accordingly.
