Digital/Soft copy of the theory Answer books are to be preserved for a period of 6 months from the date of publication of the Examination results vide paper read (1) above . As per Examination Manual, the Answer Books are also to be preserved only up to 6 months from the publication of the Examination results.

2. Of late, the numbers of Fresh valuations are increasing exponentially it has become cumbersome to keep aside the original Answer Books of Fresh valuation again for a further period of 6 months from the date of publication of Fresh Valuation results.

3.The 37th meeting of Board of Examinations held on 14/12/2023, recommended to preserve the Digital/Soft copy of the Fresh Valuation Answer books for a further period of 6 months only from the date of publication of the Fresh Valuation results, vide paper read as (2) above.

4.The 77th meeting of the Governing Council held on 21/12/2023 has considered the aforementioned recommendations of BoE and resolved to approve the same, vide paper read as (3) above.

5.The Hon'ble Vice Chancellor has accorded sanction to implement the above decision of the Governing Council with respect to Preservation of the Digital/Soft copy of the Fresh Valuation Answer books for a further period of six months from the date of publication of the Fresh Valuation results .
