## ABSTRACT

**KUHS – Exam General – Allowing colleges to copy examination visuals to a pen drive/flash drive instead of CD/DVD and the purchase of antivirus software -Orders issued.**

### ORDER

Some colleges have highlighted the non availability of CD/DVDs in the market for copying examination visuals conducted by the University. Consequently, colleges have expressed their willingness to submit examination visuals through a pen drive/flash drive. However, this raises concerns about virus threats when connecting the pen drive to a university computer, as presently there are no antivirus software options available in the University.

2. In these circumstances, the 37<sup>th</sup> meeting of Board of Examinations held on 14/12/2023, vide paper read as (1) above discussed the matter in detail and decided to permit the colleges to copy examination visuals to a pendrive/flash drive instead of using CD/DVDs. The BoE also decided to purchase antivirus software for scanning these pendrive/flash drive submitted by colleges. Besides this, BoE recommended to insist colleges to scan the pendrive/flash drive with antivirus software in order to ensure that they are virus free before submitting to the university.

3.The 77<sup>th</sup> meeting of the Governing Council held on 21/12/2023 has considered the recommendations of BoE and resolved to approve the same, vide paper read as (2) above.

4.The Hon'ble Vice Chancellor has accorded sanction to implement the above decision of the Governing Council with respect to allowing colleges to copy examination visuals to a pen drive/flash drive instead of CD/DVD and the purchase of antivirus software for scanning these pendrive/flash drive submitted by colleges.

5. Examination General B & IT Sections are directed to take further necessary actions in this regard.

6. Orders are issued accordingly.
