ORDER

The Chief Superintendent of Second Year BDS Degree Supplementary Examinations, Kannur Dental College, informed that during the examination of "General and Dental Pharmacology and Therapeutics" instead of 2016 scheme question paper (QP code - 213002), 2010 scheme question paper (QP code - 203002) was issued to the student :Asna Fathima Baker (Register No. 190020732) of Kannur Dental College, Anjarakandi, Kannur. The mistake was identified only after the end of the examination.

2. The 147th and 149th meetings of the Mal Practices & Lapses Enquiry Committee recommended to physically evaluate the written answer book of the candidate as per 2010 scheme itself and to convert the total marks scored by the candidate for the paper "General and Dental Pharmacology and Therapeutics" from 'out of 100' to 'out of 70' as per mathematical calculation and to declare the candidate's result after awarding the converted marks subject to the ratification of the Board of Examinations and the the result was published accordingly.

3. The 37th meeting of Board of Examinations held on 14/12/2023 vide paper read (1) above has ratified the action of arithmetical conversion of marks of Asna fathima baker (190020732), second year BDS Degree supplementary examinations (2019 admission) July 2023 from 2010 scheme to 2016 scheme .

4. The 77th meeting of the Governing Council held on 21/12/2023 vide paper read as (2) above has considered the aforesaid recommendations of the BoE and resolved to approve the same.

The Hon'ble Vice Chancellor has accorded sanction to implement the above decision of the Governing Council with respect to ratifying the action of arithmetical conversion of marks from 2010 scheme to 2016 scheme of Asna fathima baker (190020732, D 10), Second Year BDS Degree Supplementary examinations (2019 admission), July 2023 and to publish the result accordingly.
