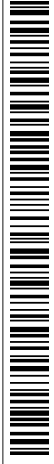

ORDER

As per the Kerala University of Health Sciences Act, 2010, vide read (2) above, a Research Council has to be constituted consisting of the Vice chancellor, Pro Vice Chancellor, Heads of the University Departments and Directors or eminent scientists from the Research Institute within or outside Kerala. The members of the Research Council shall be nominated by the Vice Chancellor in consultation with the Governing Council.
