ORDER

1. As per the order read 1st various Faculties of the Kerala University of Health Sciences were constituted for a period of three years with effect from 21.07.2018 The Dean, Faculty of Homoeopathy, Dr.K.L.Babu, Professor & HOD, Dept. of Organon (included in the capacity as BOS Homoeopathy-PG) Chairperson and the Faculty member, elected from Board of Studies-Homoeopathy-PG, Dr.Vishnu.P.Professor & HOD, Dept of Materaia Medica, Govt. Homoeopathic Medical College, Kozhikode had retired from Govt. service on 30.04.2019 and 31.05.2019 respectively.

2. As per the Section 39 (11) of Kerala University of Health Sciences Act, 2010, the Hon'ble Vice Chancellor has nominated Dr. Rithesh.B, Professor, Dept. of Organon of Medicine, Govt. Homoeopathic Medical College, Kozhikode **as the Chairperson of Board of Studies Homoeopathy-PG** against the vacancy arising on account of retirement of Dr..K.L.Babu and Dr. Abdul Hameed. P. Professor and HOD, Dept. of Practice of Medicine of Medicine, Govt. Homoeopathic Medical College, Kozhikode as the member from **Board of Studies Homoeopathy-PG in to the Faculty of Homoeopathy** against the vacancy arising on account of retirement of Dr.Vishnu.P

4. In the above circumstances, Dr. Rithesh.B, Professor, Dept. of Organon of Medicine and Dr. Abdul Hameed. P. Service.
