ORDER

1. As per the order read 1st above, various Boards of studies of the Kerala University of Health Sciences were constituted for a period of three years with effect from 20.06.2018. As per the letter cited 2nd Dr. Nileena Koshy, Professor of Community Medicine has submitted her resignation from the position held by her and the Hon'ble Vice Chancellor is pleased to accept the resignation of Dr. Nileena Koshy.

nominated Dr. Devarajan, Professor of Radiodiagnosis, Govt. Medical College, Kozhikode and Dr. Vijayakumar, Professor of Paediatrics, Govt. Medical College, Manjeri as the members in the Board of Studies Medical -PG against the vacancy arising on account of changing of positions of Dr. K.Mohanan (assumed the charge of new Vice Chancellor, KUHS) and and Dr. Lalitha Kailas (assumed the charge of Principal). The **Hon'ble Vice Chancellor has also nominated Dr. Anish.T.S,** Assistant Professor, Community Medicine, Govt. Medical College, **Thiruvananthapuram as the member in the BOS- Medical -Pre clinical-PG** against the vacancy arising on account of resignation of Dr. Nileena Koshy.

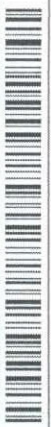
