As per the reference read 1st above, the Board of Studies Homoeopathy (UG) had recommended to delete the scheme of question paper (Theory) in the BHMS syllabus, since the present scheme of question paper is highly restrictive in nature and does not assess the knowledge of students in a broad manner, as is expected from a Medical Course.

As per the reference read 2nd above, the Faculty of Homoeopathy too endorsed the proposal of the BoS above .

As per the reference read 3rd above, the 20th Academic Council approved the minutes of Board of Studies (Homoeopathy-UG) and the Faculty of Homoeopathy).

As per the reference read 4th above,the 52nd Governing Council approved the recommendation of the Academic Council and the same was implemented vide University Order read 5th above.

Accordingly, the Faculty of Homoeopathy, vide Email read 6th above, has now submitted the modified syllabus of BHMS course and recommended to implement the same from 2019-20 admission onwards.

In the circumstances, sanction is accorded by the Hon'ble Vice Chancellor for modifying the syllabus of BHMS course from 2019-20 admission onwards, as decided by various academic bodies and the Governing Council. (The updated syllabus is annexed herewith)
