ORDER

The Course Regulation for M.Phil Clinical Epidemiology (Part Time) approved by the 21st Academic Council dated 21.05.2019 vide Decision No:21.06 and 54th Governing Council dated 24.05.2019 vide Decision No:54.07 was laid before the 8th meeting of the Senate held on 20.02.2021. The Senate has resolved to publish the Regulations in the Gazette after effecting modifications if required at par with General Regulations the University/Act/Statute.Accordingly with PVC, Registrar, meeting was a convened Rajamohanan K, Dr Sankar (Dean-Faculty of Paramedical and Allied Health Sciences), Dr.Harikumaran Nair (External Expert), concerned sections of Examination branch and IT wing .The Regulations were modified incorporating the suggestions of the meeting and removing certain clauses which are against the General Regulations. Vide paper read as (2, above, the syllabus of the said course was implemented . The Scheme, Schedule of examination and the examination related matters were removed from the Regulations and added to the syllabus part.

As per the paper read as (3) above, sanction has been accorded by the Hon'ble Vice Chancellor by exercising the powers vested with him as per section 12(7) of KUHS Act , to implement the modified Regulations and Syllabus of M.Phil in Clinical Epidemiology from 2020–21 Academic Year onwards, subject to ratification by Faculty of Paramedical and Allied Health Sciences, Academic Council and Governing Council.

As per the paper read as (4) above, Faculty of Paramedical and Allied Health Sciences has approved the modified Regulations and Syllabus of M.Phil in Clinical Epidemiology (Part Time) from 2020–21 Academic Year onwards and recommended to forward the same to School Board for School of Public Health for further action. Accordingly the same were placed in the School Board for School of Public Health and vide paper read as (5) above, the Board recommended the modified Regulation & Syllabus for M Phil Clinical Epidemiology (part time) Course (2020–21 Academic Year onwards) in order to place before the forthcoming Academic Council. It was also suggested that the course shall be opened to the professionals under DHS, Govt. of Kerala and private practitioners.

Vide Decision read as (6) above, the decision of the Academic Council is as follows:

- 1. Ratified the action of Hon'ble Vice Chancellor in approving the Regulations for MPhil (Part Time) Clinical Epidemiology course (2020–21 Academic Year on wards), modified after removing certain clauses at par with General Regulations and incorporating the modification.
- 2. Recommended to have 50% reservation for faculties of the affiliated colleges of KUHS who are registered in the Faculty Enrolment Program and 50% open (including faculties of the affiliated colleges of KUHS who are registered in the Faculty Enrolment Program).

Since the aforesaid recommendation of the Academic Council was placed before the 67th Governing Council meeting held on 30.12.2021 for approval, the Governing Council vide Decision read as (7), has approved the same.

Accordingly, vide reference (8) above, sanction has been accorded by the Hon'ble Vice Chancellor for implementing the Decision No:67.35 of the 67th Governing Council Meeting dated 30.12.2021 in approving the Academic Council Decision No:28.05 dated 18.12.2021.

The University Order read as (3) is thus made absolute.

Sanction is further accorded for adding the following decision of the Governing Council in having approved the recommendations of the academic Council,i.e, " 50% reservation for faculties of the affiliated colleges of KUHS who are registered in the Faculty Enrolment Program and 50% open to those satisfies the eligibility criteria fixed for the course as per clause 1.1 of the approved Regulations for MPhil Clinical Epidemiology course (including faculties of the affiliated colleges of KUHS who are registered in the Faculty Enrolment Program)"

Orders are issued accordingly.
