ORDER

The 34th Academic Council, vide paper read (1) above, decided to start new course B.Sc. Nuclear Medicine Technology from the ensuing academic year onwards and to entrust BoS Radiation and Imaging Sciences to prepare MSR, Syllabus, Curriculum, Inspection Proforma and Regulations of the course.

- 2. Accordingly, vide paper read (2) above, a committee was constituted to prepare Syllabus of B.Sc. Nuclear Medicine Technology course.
- 3. Then, the committee has submitted the syllabus of the course and the Board of Studies Radiation and Imaging Sciences meeting, vide paper read (3) above, approved the syllabus of the course with a modification that only internal examination is required for the foundation courses in first year.
- 4. Subsequently, the committee made the above modification in the syllabus which was placed before the Faculty of Allied Health Sciences meeting held on 20-05-2024. Faculty of Allied Health Sciences, vide paper read (4) above, has approved the recommendation of Board of Studies and 37th Academic Council meeting held on 11-06-2024, vide paper read (5) above, has approved the same.

Since admission to Allied Health Sciences courses to 2024-25 academic year commences soon, considering the urgency, Hon'ble Vice Chancellor has accorded sanction to implement the above Academic Council decision.

In these circumstances, the following orders are issued:-

- i. The syllabus of B.Sc. Nuclear Medicine Technology course is implemented subject to ratification by Governing Council. (Syllabus appended herewith)
- ii. The syllabus will be in force from 2024 admission year onwards.
