3. The application fee for starting new Medical PG courses should be remitted as **DD in favour of the Registrar, Kerala University of Health Sciences** payable at SBI, KUHAS branch, Thrissur. The rates of fee for Government colleges and Self Financing Colleges will be as per **annexure number II and III respectively in the U.O.No.6296/AC.B/KUHS/2013 Dated 31.07.2018**.
4. **Last date of submission of online application with requisite documents and fee is 06.02.2019,5 pm.**
5. The applications received before 06.02.2019,5 pm through online will only be considered.
6. **The list of mandatory documents/certificates to be submitted along with the application are mentioned in the appendix A . The applications without the documents and requisite fee will be summarily rejected.**
7. **The application is valid for 3 years.**
8. **The hard copy of application submitted online along with DD and attested copies of documents mentioned in the list of enclosures should be submitted in the University on or before 12.02.2019.**
