## NOTIFICATION KUHS-STUDENTSHIP-2019

Applications are invited for "KUHS STUDENTSHIP" for the year 2019 through online from undergraduate students having annual family income not exceeding ₹ 50,000/- (Rupees fifty thousand only) and admitted under Government Merit Quota during the academic year 2018-19. This scheme is instituted for the benefit of economically backward students of the affiliated institutions of Kerala University of Health Sciences by way of financial support to them as per Section-6(xxii) of the Kerala University of Health Sciences Act, 2010. The students shall submit the applications as per the Rules, Regulations and Instructions attached with the notification.

Online applications format will be available in the student's login of KUHS website (<a href="http://14.139.185.150/student/main/frame.html">http://14.139.185.150/student/main/frame.html</a>). The students may submit their applications along with the original digitally signed income certificate issued by the Revenue Authority to the Principal concerned by both online and offline. The Principal shall submit the applications with recommendation through online portal **on or before 13<sup>th</sup> August, 2019** and forward the hard copy of the application and digitally signed original income certificate duly attested by him and forward to Dean, Student Affairs so as to reach him **on or before** the **20<sup>th</sup> August, 2019 5 PM**.

## I. RULES AND REGULATIONS

- 1. The Under Graduate students **who got admission during the previous Academic Year (2018 admission)**, admitted under Govt. Merit quota of all streams and whose annual family income not exceeding Rs.50,000/- are eligible to apply for the assistance under this scheme.
- 2. Students admitted under management or NRI seat are not eligible to apply for this scheme.
- 3. If the total claim from the eligible students exceeds the amount earmarked by the University, the University shall have the right to fix scientific criteria to select the students eligible for assistance.
- 4. Students who have received any financial assistance from Government or any other agencies in the name of "STUDENTSHIP" during the course are not eligible for this scheme. However those who received any other scholarship (other than studentship) are eligible to apply for the "KUHS-STUDENTSHIP" scheme.
- 5. A monitoring committee comprising of the Vice Chancellor, Pro Vice Chancellor, Registrar, Finance Officer and Dean Student Affairs will finalize the eligible candidates list and publish the same in the website.
- 6. The amount of Studentship will be given to the students by way of cheque/NEFT to the Bank Account number of students if provided by them.
- 7. The students must have Bank Account in their name otherwise they shall not be eligible to receive KUHS-STUDENTSHIP.
- 8. In the event of discontinuation of the course for which they receive Studentship, detection of any misbehaviour or any similar occurrence as determined by the University, the University shall have the right to stop/cancel/withdraw the payments of assistance to such students. In such event, it shall be the responsibility of the student concerned to refund the assistance to the University through the Principal immediately.
