**ORDER**

As per U.O read as 1<sup>st</sup> above, the University has fixed the rate of fee to be remitted by Government and Aided colleges for affiliation and allied matters of various courses and the same was continued during the year 2017-18 also. As per the order read 2<sup>nd</sup> above, the University has fixed the rate of fee to be remitted by self financing colleges for affiliation and allied matters of various courses for the year 2017-18. The Governing Council has decided to invite application for new courses and enhancement of seats for the year 2018-19 ( Nursing, Pharmacy and Paramedical courses) and for 2019-20 ( Medical, Dental and AYUSH courses) and giving 15 days period of submitting applications. The Governing Council has also decided to constitute a sub committee of the Governing Council with the following members for overseeing the procedural aspects of inviting and processing of application during the year 2018-19.

The sub committee met on 29.12.2017 and recommended to invite applications for starting new courses/enhancement of seats for the year 2018-19 with the certain conditions fixed by the committee. The Committee has also recommended to continue the existing fee for starting new course/enhancement of seats for the year 2017-18 in

the year 2018-19 also, since the revision of fee for affiliation and other related issues is not finalized.

Sanction has been accorded by the Hon'ble Vice Chancellor to implement the recommendation of Sub Committee of Governing Council to continue the fee for affiliation and allied matters for the year 2017-18 in the year 2018-19 also for self financing colleges and for the fee for Government and Aided colleges as fixed vide order read 1<sup>st</sup> above, subject to ratification of Governing Council.

Accordingly, the fee for affiliation and allied matters for self financing colleges affiliated to this university for the academic year 2018-19 are fixed, as detailed below:-

- 3) Annual administration fee should be paid before the registration of the students in the University.
