ORDER

1. The Director, College of Nursing, EMS Memorial Co-operative Hospital, Perinthalmanna Malappuram, vide paper read (1) above applied for enhancement of seats of B.Sc. Nursing Degree course from 50 to 75 with the required documents.

2. The application was processed by the University and the Inspection Commission constituted by this University had conducted inspection in connection with granting of Provisional Affiliation. The inspection report submitted vide paper read as (3) was scrutinised by the scrutiny committee. The scrutiny Committee meeting dated 25/5/2017 pointed out the deficiency of six faculties for conducting the existing Nursing courses viz, B.Sc. (N), P.B.B.Sc.(N) and M.Sc.(N). The deficiencies pointed out by the scrutiny committee was intimated to the college for rectification. In compliance to this, the Principal, EMS College of Nursing, Perinthalmanna had forwarded the rectification report vide paper read 4th above wherein it is stated that the Director Board of the college had decided to stop admission to P.B.B.Sc. and M.Sc. Nursing courses from 2017-18 and there is no need for appointment of six more faculties and requested to grant Provisional Affiliation of B.Sc. Nursing seats from 60 to 70. The compliance report was scrutinized by the scrutiny committee and the committee recommended that the deficiency of 6 faculty can be compensated either by appointment of faculty or on stopping Post Basic B.Sc Nursing - 30 seats and M.Sc Nursing Courses (Medical Surgical - 4 seats, OBG - 4 seats, Child health - 4 seats, Mental health - 4 seats).

3. As per the clause 12(2) of Chapter XXI of Statute of Kerala University of Health Sciences no course of study shall be abolished in any college without the prior approval of Governing Council. As directed, the Director Board of EMS College of Nursing, Perinthalmanna, Malappuram has forwarded the resolution of the Trust vide paper read (7) above to stop the courses of P.B.B.Sc and M. Sc. Nursing from 2017-18. The Government vide paper read as (8) above had issued orders to stop P.B.B.Sc. and M. Sc. Nursing courses at EMS College of Nursing, Perinthalmanna, Malappuram from the academic year 2017-18 so as to increase the number of B.Sc. nursing seats which should be produced before the Governing Council in connection with the closing down of P.B.B.Sc. and M.Sc. Nursing courses and for granting provisional affiliation for B.Sc. (N) for the enhancement of seats from 50 to 70.

4. The Indian Nursing Council vide paper read (5) has granted permission for enhancement of seats of B.Sc. Nursing course from 50 to 70 during the year 2017-18. The Registrar, Kerala Nurses



and Midwives Council has also granted sanction for enhancement of seats of B.Sc. Nursing course from 50 to 70 during the year 2017-18 as per paper 6th above.

5. The Director, College of Nursing, EMS Memorial Co-operative Hospital, Perinthalmanna, Malappuram has remitted an amount of Rs. 1,00,000/- (Rupees One Lakh only) towards the Provisional affiliation fee and Rs. 2,00,000/- (Rupees Two lakhs only) towards Refundable Deposit in connection with the enhancement of seats of B. Sc. Nursing course from 50- 70.

6. After considering the matter in detail, sanction has been accorded by the Vice Chancellor by exercising the powers conferred under section 12(7) of Kerala University of Health Sciences Act, 2010 to grant provisional affiliation to College of Nursing EMS Memorial Co-operative Hospital Perinthalmanna Malappuram for enhancement of seats of B.Sc. Nursing course from 50- 70 for the academic year 2017-18 subject to ratification of the Governing Council and based on the conditions mentioned below:-

1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
3. Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
4. Admission to the next academic year shall be made only after obtaining prior permission from the University.
5. The college should remit Annual Administration fee fixed for UG Course for the academic year 2017-18.
6. The College should collect fees**from the students to be remitted to this University as follows:-
