ORDER

1.As per the 1st order read above, a six member committee was constituted for preparing a detailed and realistic fee structure in comparison with other Health Sciences Universities .The recommendations of the committee was placed before the 17th Academic Council meeting held on 03.11.2017 and vide decision read 2nd paper above the Academic Council has accepted the recommendations in principle and resolved to propose and recommend fee revision.

3. Vide paper read 3rd above, the Governing Council had decided to constitute a sub committee of the Governing Council to study the proposal for the revision of fee for affiliation and allied matters and to make necessary recommendations. The Governing Council has also authorized the Hon'ble Vice Chancellor to nominate the members. Accordingly vide order 4th above, a three member sub committee of Governing Council was constituted under the Chairmanship of Pro-Vice Chancellor. The sub committee of Governing Council has submitted their recommendations including fixing of fee for PG Ayurveda Diploma courses.

4.The recommendations of the sub committee of the Governing Council was placed before the 47th Governing Council meeting held on 07.07.2018 and the Governing Council vide decision read 6th above, after detailed discussion and consideration of minutes of sub committee of 29th Governing Council for preparing a detailed and realistic fee structure in comparison with other Health Universities, subsequent sub committee of the 42nd Governing Council on revision and reconsideration of fee for affiliation and allied matters and also Government Order No.44/2018/Fin Dated 17.03.2018, took an informed

decision to limit the enhancement of fee for affiliation and allied matters from the year 2019-20 onwards to 5% of the existing fee and the fraction will be rounded to next 100. The Governing Council has also decided to accept the recommendations of Sub committee of Governing Council in fixing the fee for affiliation and allied matters of PG Ayurveda Diploma course.

7. Sanction has been accorded by the Hon'ble Vice Chancellor to implement the above said decision of the Governing Council in fixing of fee for affiliation and allied matters from the year 2019-20 onwards, as appended.
