ORDER

Vide paper read as (1), the University has invited applications for provisional affiliation to new Pharmacy courses/colleges for the academic year 2014-15.

The Executive Trustee, KMCT College of Pharmaceutical Sciences, Kalanthode, Kozhikode-673 601 has applied for Provisional Affiliation for starting KMCT College of Pharmaceutical Sciences, Kalanthode, Kozhikode offering B.Pharm course for the year 2014-15 vide paper read (2) above. The application was verified and processed by the University and the inspection commission constituted for examining the feasibility of starting Pharmacy college offering B Pharm course and scrutiny committee has recommended the course in KMCT College of Pharmaceutical Sciences, Kalanthode, Kozhikode-673 601 as per paper read (3) above.

As per paper read (4) the institution has submitted the approval orders from AICTE and PCI and they have remitted the necessary fee towards Provisional Affiliation and Refundable Deposit.

Under these circumstances, Sanction, has, been accorded by the Hon'ble Vice-Chancellor by exercising his powers under section 12(7) of KUHS, 2010 for granting provisional affiliation to KMCT College of Pharmaceutical Sciences, Kalanthode, Kozhikode-673 601 for conducting the B.Pharm course with an annual intake of 60 seats during the academic year 2015-16 subject to the conditions mentioned below:-

- Selection admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the direction issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.
- In the light of the direction of the Supreme Court of India in Writ petition (c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2015-16 The

college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the University.

- The admission to the next academic year shall be made only after obtaining prior permission from the University.
- The college should comply with the direction issued by the University & Government of Kerala.

The Principal should collect the following fees from the students (one time payment at time of admission) and should remit the same to the University after the closure of the admission.
