## **ORDER**

The Principal, Lourdes College of Nursing, Ernakulam vide paper read as (1) above, applied for enhancement of seats for B.Sc. Nursing degree course from 50 to 100 on remitting the required application fee.

The Government vide paper read as (2) have issued orders for enhancement of seats of B.Sc Nursing course from 50 to 100 without mentioning the academic year.

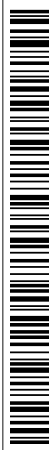
The application was processed by the University and the inspection Commission submitted the report vide paper read (3) was scrutinized by the Scrutiny Committee on 06.07.2017 and the deficiencies pointed out by the Scrutiny Committee was intimated to the college for rectification. The compliance report submitted by the college vide paper read (5) was again scrutinized by the committee and the committee vide paper read as (7) recommended to grant Provisional Affiliation for the enhancement of seats of B.Sc. Nursing Course from 50 to 70 for the academic year 2017-18 subject to approval of INC/KNMC.

The Government vide paper read as (6) have issued re-validated No Objection Certificate for the academic year 2017-18 for enhancement of seats of B.Sc. Nursing course from 50-100.

The Indian Nursing Council vide paper read as (8) above has granted permission for enhancement of seats of B.Sc Nursing course from 50 to 100 during the academic year 2017-18. The Registrar, Kerala Nurses and Midwives Council has also granted sanction for enhancement of seats of B.Sc Nursing course from 50 to 100 during the academic year 2017-18 vide paper read as (9).

The whole matter was placed in the Governing Council and the Governing Council vide paper read as (10) above decided to grant Provisional Affiliation for enhancement of seats of B.Sc. Nursing course from 50 to 70 for the year 2017-18 to Lourdes College of Nursing, Ernakulam.

The Principal , Lourdes College of Nursing, Ernakulam has remitted an amount of





Rs. 1,00,000/- (Rupees One Lakh only) towards the Provisional affiliation fee and Rs. 2,00,000/- (Rupees Two lakhs only) towards Refundable Deposit in connection with the enhancement of seats of B. Sc Nursing course for the academic year 2017-18.

**Sanction, has, therefore been accorded by the Vice-Chancellor by implementing the said decision of the Governing Council to grant provisional affiliation to Lourdes College of Nursing, Ernakulam for enhancement of seats of B.Sc. Nursing course from 50 to 70 for the academic year 2017-18 subject to the following conditions:-**

1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
3. Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University along with a copy of letter of approval from the apex bodies concerned.
4. Admission to the next academic year shall be made only after obtaining prior permission from the University.
5. The college should remit Annual Administration fee fixed for UG Course for the academic year 2016-17.
6. The College should collect fees\*\* from the students to be remitted to this University as follows:-
