ORDER

1. As per the paper read (1) above, University had permitted those teaching faculty, who have acquired the three year B.Sc. MLT Degree before 2002 and who are continuing as the faculty of B.Sc. MLT programme of KUHS to continue as teaching faculty under the affiliated colleges of KUHS. This exemption was not extended to any new teaching faculty appointed with similar degrees later.

2. Some faculties in the affiliated colleges of KUHS, badly affected by the said University order had represented before the University protecting their service by revising the order. Accordingly the matter has been discussed in the 34th Governing Council and the Governing Council decided to allow the faculty with B.Sc. MLT degree of three year duration and who are now in the service in the affiliated colleges of the University on or before 29/10/2015, the date of the University Order implementing the decision of the Academic Council and Governing Council, to continue as teaching faculty.

3. The above matter on discussion in Board of Studies meeting held on 29/09/2016 resolved that the 3 year B.Sc. MLT degree after 2002 should not be accepted as the qualification for the post of teaching faculty for 4 year B.Sc. MLT course in KUHS and the same was approved by the Faculty meeting held on 29/09/2016 and the Academic Council held on 08/11/2016 vide papers read (4)&(5) above.

4. Under these circumstances, the 35th meeting of the Governing Council reconsidered the whole matter in detail and decided to uphold the earlier decision of the 9th Academic Council to permit only the faculty who obtained three year B.Sc. MLT degree before 2002 and now continuing as the faculty of B.Sc. MLT programme in KUHS and not to extend this to any new teaching faculty appointed in the affiliated

colleges of KUHS with similar degrees. This decision of the Governing Council was implemented vide order read (6) above.

5. The qualification for the teaching faculty of B.Sc. MLT Course in KUHS is fixed accordingly.
