## NOTIFICATION

Sub:- Election of Dr.K.George Varghese, Principal, Govt. Dental College, Kottayam as the representative of KUHS to the Dental Council of India from amongst the members of the Dental Faculty of the University by the Governing Council-Reg.

As per Clause (d) of Sn.3 of Dentist Act 1948 and as per section 24 of DCI Election Regulations, 1952 with its amendments, one member from each University established by law in the states which grants a recognised Dental qualification, is to be elected by the members of Senate of the University, or in case the University has no Senate, by the members of the Court, from amongst the members of the Dental Faculty of the University or in case the University has no Dental Faculty, from amongst the members of the Medical Faculty thereof.

Accordingly, the Hon'ble Vice-Chancellor has approved the election notifications with programme of election, vide paper 3rd read above. After the date fixed for scrutiny of nomination and the last date fixed for withdrawal of candidature, Dr. K George Varghese, Principal, Govt. Dental College, Kottayam, was validly nominated for election of a representative of KUHS to the DCI from amongst the members of the Dental Faculty of the University by the Governing Council, as the Senate of the University was not constituted.

The election was fixed on 30-05-2016 at 11 am in Mascot Hotel, Thiruvananthapuram and Dr. A. Nalinakshan, Pro Vice-Chancellor & Registrar(i/c) has been appointed as Returning Officer of this election.

As per the minutes of the 32<sup>nd</sup> meeting of the Governing Council held on 30-5-16, read above, it is notified that the following member of the Faculty of Dental Science of KUHS has been duly elected to the Dental Council of India by the Governing Council of the University in accordance with clause(d) of section 3 of the Dentist Act 1948 and as per Section 24 of DCI Election Regulations 1952 with its amendments.
