### ORDER

Vide paper read as 1 above, Board of Adjudication for Students Grievances recommended 6 months period as cut off (from the date of examination) to submit the grievance, if any and was approved by 59th Governing Council held on 25.04.2020. And as per the U.O read as (2) above, the 67th Governing Council held on 30.12.2021, approved the recommendations of the board that, the exam related grievance applications should be submitted within 3 months from the date of publication of examination result to the University and late applications will not be considered.

Vide paper read as 3 above, KUHS Students Union 2024-25, submitted a request regarding the delay in considering the requests received before the Board of Adjudication for Students Grievances and thereafter the delay in publishing the results after fresh valuation.

The board noticed that submitting grievance applications pertaining to examinations even after 3 months of publication of results leads to delay in considering such cases and in further procedures, before the next examinations.

Considering the matter in detail, In order to avoid such delay the Board recommended that the exam related applications to Board of Adjudication for Students Grievances should be submitted within a period of one month after the date of publication of result and not to consider the late applications, vide the paper read (4) above.





As per paper read as 5 above, sanction has been accorded by the Hon'ble Vice Chancellor to implement the recommendation of the board forth with subject to ratification by the Governing Council.
