ORDER

Governing Council vide decision read (1) above approved the fee structure for PhD program and accordingly University order read (3) above was issued . Later Governing Council vide decision read(2) above decided to enhance the fees for various service rendered by University by 5% with effect from the academic year 2020-21. The Hon'ble Vice Chancellor has accorded to sanction to implement the above decision of GC and to enhance the fee for PhD Programme by 5% with effect from 1.4.2020.

2. In the above circumstances, the fee Structure for PhD programme is modified as detailed below-
